We lobby* for and against legislation and regulations to help or protect the industry.

Below are <u>just some examples</u> of new state laws we got adopted in recent years. ...

... But many of our successes go unseen. We play a lot of defense and defeat numerous proposed laws and regulations the industry never has to face.

Land Development & Permitting

- Reformed 22a-19 environmental interventions to require petitions to state specific facts about alleged harm, and more...
- Required state agencies to identify specific statutory & regulatory authority when regulating businesses or land owners
- Limits state agency's use of State Plan of C&D's locational guide map when making funding and permit decisions
- Greatly improved performance bonds/financial guarantees developers provide to municipalities
- Streamlined DEEP's construction stormwater general permit, shaving months off the process
- Got automatic 9-year permit extensions for site plan, subdivision and wetland permits
- Coordinated wetland permit expiration dates with site plan and subdivision approvals; required PZC to accept and process applications even if a wetland app is pending; defeated 200' buffer, no-touch zones ... 5 times
- Substantially streamlined STC permit requirements; no longer applicable to developments of 100 homes or less
- Created uniform land use notice requirements repealed procedural pitfalls, and established a public notice registry so PZCs work in the open

- Adopted HOME CT Incentive Housing program
- Prevented DPH from requiring paper reviews of routine water main distribution installations

Building Codes & Construction

- Helped shape new law requiring smoke & CO detectors in homes during home improvement work, averting original proposal's code nightmare for contractors
- Fixed green building code requirements, establishing statutory recognition for the NAHB RC Nat'l Green Building Standard (NGBS)
- Got the CT Codes & Standards Committee to remove mandatory fire sprinklers from the 2009 IRC

Business Operations

- Got the state to adopt all 4 federally permissible options to comply with new OSHA regs on crane operators; original bill would have required all operators to be licensed
- Amended the law to allow developers to market and sell, but not transfer, lots prior to final subdivision approval
- Improved the handling of consumer complaints at Consumer Protection; Got favorable changes to registration laws for home builders and home improvement contractors
